NAME THE CRANE COLOURING COMPETITION TERMS AND CONDITIONS

1. By entering the Name the Crane Colouring Competition (the Competition), an entrant is indicating his/her agreement to be bound by these terms and conditions.
1. The purpose of the Competition is to name the tower crane on the Griffith Base Hospital Redevelopment site.
2. Entries are open to primary school children in Griffith and surrounding communities within the Murrumbidgee Local Health District (MLHD) in the LGAs of Griffith, Leeton, Narrandera, Murrumbidgee, Bland, Lachlan, Carrathool and Hay. Child patients in the Griffith Base Hospital Paediatric Unit are eligible to enter the Competition.
3. The Competition is being run by MLHD.
4. The Competition closes 5pm, Friday 26 August 2022. After this date no further entries to the Competition will be permitted.
5. Winners of the Competition will be notified by telephone or email within 28 days of the closing date.
6. No responsibility can be accepted for entries not received for whatever reason.
7. Entry forms can be downloaded from the Griffith Base Hospital Redevelopment website or can be requested via email HI-GBHRedev@health.nsw.gov.au
8. To enter the Competition, entrants must name the tower crane on the Griffith Base Hospital Redevelopment site, colour in the crane on a downloaded entry form, complete their details including name, age, school and get signed parent/guardian permission.
9. Entrants must email or mail their completed entry forms to: Name the Crane, Griffith Base Hospital, Noorebar Avenue, Griffith, NSW, 2680 or drop it at main reception, Griffith Base Hospital, Griffith, NSW.
10. Each entrant may only enter the Competition once. Multiple entries from the same person will be disqualified.
11. Prizes include the opportunity to name the tower crane on the Griffith Base Hospital Redevelopment site, have that name displayed on the crane, attend the official crane naming ceremony, and receive a special prize.
12. The prizes are as follows:
 - a. BEST CRANE NAME:

\$1000 book or sporting goods voucher for the school of the overall winner for best crane name.

Winner \$100 voucher

Runner-up \$30 voucher

b. BEST COLOURING

Winner \$50 voucher

Runner-up \$30 voucher

c. EXTRA EFFORT

Winner \$50 voucher

Runner-up \$30 voucher

Vouchers are for book, toy or sporting good vouchers

13. The entry must be the entrant's own original work and has not been copied from any other work.

14. Each entry is the property of MLHD and it has no obligation to return any entry to an entrant.

15. Judging will be conducted by a 3-member panel including representatives of the Griffith Base Hospital, ADCO Constructions and Griffith Local Health Advisory Committee.

16. Entries will be judged on artistic merit given the child's age and the creativity of the crane name. The judging panel's decision is final and no correspondence will be entered into.

17. Entries which are incomplete, incorrect, offensive, non-serious or incomprehensible will be ruled ineligible.

18. Any personal data relating to winners or any other entrants will be used solely in accordance with current Privacy and Personal Information Protection Act 1998 and will not be disclosed to a third party without the entrant's prior consent.

19. The winner consents to the announcement and promotion of the winning entrants name, school and age and publication of the winning entry in all media channels, including social media.

20. There is no entry fee and no purchase necessary to enter this Competition.

21. Prizes are not transferable or exchangeable and cannot be taken as cash.

22. Collection of prizes will be from Griffith Base Hospital. Any transport costs or ancillary costs to attend an official crane naming ceremony at the Griffith Base Hospital are the winner's responsibility.
